# **Estate Planning Q & A**

Q. How do I know when it's time to update my Estate Plan?

**A.** There are a number of reasons why you may need to update your Estate Plan:

**Family.** Has your family situation changed? Perhaps you had small children when you first designed your Estate Plan. Now, they are grown and self-sufficient without a Bequest from you. A death in your family may have changed your situation, requiring a change to your Estate Plan.

**Finances.** Has your financial situation changed (or is it about to change)? Perhaps you are contemplating selling a business or real estate, or planning your retirement. It could be that through the Lord's blessing the size of your estate has increased so that estate and gift tax consequences are now a concern.

**Ministry.** Do you want to have a greater and more lasting impact for God's kingdom? You can, by adjusting your plan to more fully include Christian ministries. Perhaps your Estate Plan omitted gifts to Christian causes altogether. This has resulted in an Estate Plan that does not fit your values and is not the legacy you wish to leave as your last statement concerning what you believe is most important.

#### Legal Language for Naming Our Church in Your Will

If you decide to support our church with a gift from your estate, please contact our Foundation Committee. They will indicate which specific program funds within our **Legacy Foundation** are open for contributions. If you do not designate a specific fund, the Foundation Committee will decide which **Legacy Foundation** fund will receive your bequest.

Additionally, please provide your attorney with the following language to include in your bequest documents.

1.	If you did not select a specific program fund, use the following language:
